1. They will not be transferred in exchange for money, property, or services.

3. They will be distributed only to donee organizations which have legally executed a release form.
4. They must be fit for human use and will be stored properly and used as soon as possible.
5. Adequate books and records are maintained and are available to the IRS upon request.
